Residents attended to object to the Planning Application APP/2017/0494, the development of a 20mw synchronous gas powered standby generation facility. It was suggested that the application had not been well advertised and more signs should have been put up. Borough Councillors Kelly and Lishman had personally objected to the application and the Parish Council had sent in objections. The main objections were the noise pollution and the disruption of green belt land. It was suggested that the facility should be put on the industrial estate. The application does not need an outline application. Residents were advised how to raise objections and that they should form a campaign group to ensure speakers at the Development Control Committee get the best result.
